A new report says many people in Florida don't receive needed health care because they lack easy access

to adequate services. Florida TaxWatch recently released its report, Social Determinants of Health:

Health Care Access and Quality. According to the U.S. Department of Health and Human Services, social determinants of health are environmental factors

that can impact individuals' health outcomes. These include health

care access and quality; education access and quality; social and community context; neighborhood and built environment; and economic stability.

According to the report, these factors can majorly impact a person's health, wellbeing and quality of life. The report notes that 80 percent of a person's health is de-

In Florida, many people lack access to health care services, with the biggest barrier being the cost. In a 2019 survey of 1,200 Floridians, 55 percent had experienced health care cost burdens, while 78 percent worried they would not be able to afford health care in the future.



Zellwood Elementary School on achieving an "A" grade this year. Both schools worked incredibly hard to bring their grades up to this level. This is the first time Wolf Lake Middle School has been an "A" school since 2010.

For Zellwood Elementary, this grade has not been achieved since 2004! More impressive is their rise from a "D" grade in 2016, consistently improving since that grade all the way to the top with an "A" this year.

Of course, these are not our only "A" schools in Apopka. Wolf Lake Elementary kept up its consistent "A" rating again this year and our newest school Kelly Park School received its second "A" grade since opening two years ago.

But "A" grades are not the only thing to celebrate. Lakeville Elementary went up from a "C" grade to a "B" grade this year. This is the first time Lakeville has been a "B" since 2015. I'm so proud of their hard work and dedication to improvement.

The Zellwood Church of God will celebrate its 100th anniversary with a celebration all weekend.



In October of 2021, May's grandfather put down a record-breaking land speed of 244 miles per hour beating the previous record of 220 that stood untouched since 1988.
