


Let's use our Godgiven common sense when we go to vote. Remember, we all are in the same box! Get out and VOTE.

The brackets are set up like this: kindergarten through third grade, fourth grade through sixth grade, seventh through ninth grade, and then tenth grade through twelfth grade.

Two plays later, Mike Blackmon took a handoff from Jackson Keillor. By the time Blackmon reached the right side of the line, the defense had been pushed at least six inches to the other side. Blackmon bolted through the opening while reaching full speed and outran the rest of the defense to the end zone. by Keillor. The interceptions returned for touchdowns were the work of Chris Glenn (38 yards) and Jabari Smith (27). Times of the touchdowns were with 35 seconds remaining in the first half and 10:10 in the fourth quarter, respectively. Returning two interceptions for a touchdown has now been achieved during six contests in Wekiva his-

Glenn also ended the Panthers' second possession with an interception.

Then a blocked punt concluded Eustis' subsequent (third) possession.

"Over the last couple of weeks we have gotten two much needed victories," Gabriel said. "Of course, celebrating as opposed to trying to figure out what went wrong is much preferable and feels lighter. A lack of listening to the coaches and stubbornness is still present, which starts the process of committing mistakes. Performance tonight was far from consistent enough to be competitive against a lot of opponents though."

were for a touchdown.

I got to talk to Davison a little bit after the win and ask him how he felt about the offense production – especially his own.

"This was a great team win. We got the guys who needed to get in, in, and get them some reps in, and we all just balled out. I think we were all able to play so well because of a great week of preparation from the coaches down to the players, to the scout team, to the athletic trainers keeping us healthy. And when you have a week like we did, it shows on the field."

Davison showed great poise out there for most of the night until he was pulled out to give his backups some reps. Davison's highlights were his running game, especially his 38yard rushing touchdown that put up the first points of the night for the Blue Darters. Other than that he had two passing touch-

downs with both showing his ability to read the defense and place the ball only where his receiver could get it.

Davison's first passing touchdown was a 10yard completion to Noah Morgan on a beautiful corner route. The second was a huge chunk play which made the stadium roar. Sitting on Apopka's 47-yard line Apopka went with a play-action boot. Apopka lined up with a five-man front with two recovers on each side and one back in the backfield next to Davison. Before the snap, Davison called for a motion from his slot receiver on the right side who goes into a jet sweep sort of motion. Davison called for the snap – faked the handoff to the sweeping receiver – and began moving out of the pocket.

As Davison left the pocket, he was one-onone with a West Port edge rusher. With a quick move, Davison shook the West Port defender and made

him fall to his knees. As he continued to scramble from pressure, Davison saw the receiver that was set in motion upfield wide open down the sideline and heaved up a pass that ended in a 53-yard touchdown for Davison and receiver Judah Harvey. After the original sweep motion, Harvey continued upfield on a wheel route and was completely forgotten about by the West Port defenseleaving him wide open down the sideline!

Our boys in blue came out swinging last Friday during their homecoming game scoring 21 points in the first quarter. But they didn't stop there. In the second quarter, the boys scored another 21 points and went into the locker room at halftime up 42-0.

The Blue Darters went on to score one more touchdown in the third quarter, but the second half was much more about letting some of Apopka's
