## Orange County launches free financial counseling program

Orange County became the first local government in the state to launch a Financial Empowerment Center (FEC), which offers one-on-one certified financial counseling as a free public service to everyone who lives and works in Orange County.

On Wednesday, January 8, the Financial Empowerment Center was officially kicked off at the John Bridges Community Action Center in Apopka. The Bridges Center will serve as one of Orange County's three in-person sites of the Financial Empowerment Center, along with the Hal P. Marston Community Action Center and the Pine Hills Community Action Center, both in Orlando. The county plans to expand FEC services to more sites this year.

Ceremony speakers were Kate Wilson, the senior vice president for philanthropy and community impact at Wells Fargo; Catherine Steck McManus, president and CEO of Habitat for Humanity Greater Orlando & Osceola County; and Jerry L. Demings, Orange County mayor. Habitat Orlando & Osceola is the program's nonprofit provider.

The initiative is a partnership between Orange County Government, Habitat for Humanity Greater Orlando & Osceola County and the Cities for Financial Empowerment Fund.

The Orange County Financial Empowerment Center is an example of the county's ongoing efforts to help people who are struggling in the community, according to Demings. He cited that according to Heart of FloriEmployed, or ALICE.

"We will change it. We're going to lower that (percentage). We will work holistically every day to make sure the Financial Empowerment Centers provide the tools and the resources that can assist ALICE households as well ange County Financial Empowas other families and individuals struggling to reach financing specifically," the mayor said.

Piloted in New York City in 2008, FECs across the nation have worked with nearly 173,000 clients. Through the FEC, clients have reduced their personal debts by over \$276 million and increased household savings by nearly \$54 million.

Calling the launch of the Orerment Center "a truly historic day" and a "milestone," McManus explained how the financial empowerment center aligns well with Habitat Orlando and Osceola's mission. Habitat Orlando and Osceola has been building energy-efficient homes that local families purchased with an affordable mortgage. Homeowners involved in Habitat go through educational programs including helping homeowners keep their affordable mortgage through our home preservation program, including roof replacements and major home repairs.

"First, to Habitat Orlando

"Stable and accessible housing leads to better outcomes in education, health and more. But the system is broken, and we've long ago realized that we can't build our way out of the housing crisis. That's why our impact strategy to face the housing crisis focuses on two overarching goals: pioneer housing solutions and empower through knowledge."

In September 2024, Orange County Government announced that it received a \$150,000 grant to support the launch of the county's Financial Empowerment Center. The FEC movement is supported by seed funder Bloomberg Philanthropies, the Wells Fargo Foundation and other partners. The American Rescue Plan Act of 2021 provided additional funding for the project's implementation.



ditions Financial Arena at UCF. Both ceremonies will be a wonderful celebration of all that these young people have accomplished and all they have to look forward to in their bright fu-



to the grand opening early in 2025

Affordable Housing has \$16.1 allocated for 2025 from the Affordable Housing Trust Fund. This brings the county's total investment in affordable and workforce housing to \$83.8 million over six years and \$160 million over 10 years. Several projects are in progress in the Apopka and Pine Hills communities.

Green PLACE Program is one of the most impactful conservation initiatives in the budget. In 2021 the board approved \$100 million to preserve our natural habitats. So far, the county has acquired 24,000 acres and opened more than 18,000 acres for public rec-

Community and Family Services is part of the county's core mission. The adopted budget includes \$150 million which covers programs that address social challenges, child welfare, and services to preserve the high-quality of life to enrich a diverse pop-

This includes afterschool programs and summer youth programs that offer a haven, as well as community programs to provide outreach services.

As Parks & Recreation celebrates its 100th anniversary of serving residents at 113 parks and trails, the division provides a host of your recreation programs and activities. We are looking forward to the renovation of the West Orange Trail Bridge across US 441 in downtown Apopka.

Mental & Health Services has been receiving \$49 million annually for mental and behavioral health services. The county is closing the gap by providing more than \$10 million additional county general fund dollars and using various federal grant sources.

The Economic Environment includes the Orange County Convention Center and the visitors and business it attracts. Over 1,200 local businesses depend on the center's events. Funding comes primarily from the fees the center collects for services and the Tourist Development Tax (TDT) proceeds are utilized for any operating shortfalls. No property taxes are used for the convention center.

I have not yet mentioned the great work of our Utilities Department with water, sewer, reclaimed water, and solid waste.

These are large operations which must meet all their operational and capital expenses by charges and impact fees.

They are often accounted for in what is known as enterprise funds.

One of the key components of Orange County's economic development is the Travel and Tourism Industry. In 2023, Orange County welcomed 74 million visitors, generating \$92.5 billion in economic impact. Nearly 43 percent of the region's workforce works in tourism. The county has made investments in accommodations, technology, and amenities to allow the area to remain one of the top convention destinations. TDT dollars were \$350 million in FY

Universal Studios is moving forward with "Epic Universe," a new theme park opening in 2025 that is expected to bring 14,000 new jobs to the region. In addition, the new Reedy Creek or Central Florida Tourism Oversight District recently approved a new development proposal by Walt Disney Companies to spend up to \$17 billion which may include an entirely new theme park at Disney World.

The county budget is large and complex. Rest assured that competent staff, the comptroller, and commissioners provide superior guidance and oversight. As many of you have seen, we have recently provided oversight and accountability for the Supervisor of Elections Office.







still huge as Apopka scored 68 points which is tied for the most points they have scored all season with another 68-point victory over BEST in a tournament in Gainesville.
