## City Council approves apartment complex at Apopka Station Street project

The Apopka City Council voted 4-1 on approving a multi-use development planned for Station Street in downtown Apopka – known as the Apopka Station Street Project – and to proceed with its development

agreement at the Wednesday, February 21, meeting. Commissioner Kyle Becker cast the no vote.

Also on Wednesday, February 21, the Apopka Community Redevelopment Agency (CRA) Board approved 5-1 on the same proposal and to proceed with a development agreement for it. As a CRA Board

member, Becker cast the no vote at that meeting, too.

The Apopka Station Street Project proposal outlines the general design for a 60-unit, two-building apartment complex and associated parking and event space in down-

## FAMU, museum dedicate historical desk

With humble hearts, leadership at Florida A&M University (FAMU) College of Law graciously accepted the desk used by the late defense attorney Alexander Akerman, Jr., who fought against racism, prejudice, and hatred in the 1940s and 1950s. The historic desk is a gift from the Apopka Historical Society.

FAMU Law hosted a program on Thursday, February 15, where the desk was unveiled to students, faculty, staff, community partners and friends of both the Apopka Historical Society and FAMU Law.

"We are delighted to make this unique contribution to the preservation of history," President of the Apopka Historical Society Maribel Brinkle said in a news release. "This desk, once a silent witness to a crucial moment in our legal history, will now have a new home at Florida A&M University's College of

## Domestic energy war intensifies by halting of export terminal permits

On Jan. 26, President Joe Biden took an aggressive step forward in his war on American energy by halting the permitting of new liquified natural gas (LNG) export terminals. This action has massive global implications, as Texas Public Policy Foundation's Mark Mills laid out when the decision was publicly announced.

It also has the added benefit for the president of attacking primarily Texas and Louisiana, red states that account for the bulk of U.S. LNG exports. This decision comes on the heels of Texas taking steps to secure its border with Mexico, putting the state directly at odds with the administration – once again.

But the president's politically motivated actions will reverberate far beyond America's natural gas producing regions. By locking global supply and demand imbalances in place for longer, this decision will send billions of dollars to foreign producers and raise the cost of energy globally. Any short-term drop in domestic prices will ultimately be negated by reductions in future domestic production.

If this decision doesn't help Americans and hurts our allies, why do it? Politics, of course, primarily appeasing the radical green cartel that forms a key part of the president's base, and, perhaps to the surprise of a casual observer, rent-seeking industries looking to hoard short-term supply.

President Biden's environmental extremism means our allies will become more reliant on our adversaries. For context, 87 percent of US LNG exports went primarily to U.S. allies in Europe and Asia. The Biden administration blunting America's ability to participate on the world energy stage creates a vacuum that will undoubtedly be filled by the other major natural gas exporting countries – Russia, Qatar, and Iran – who are certainly not friends of the U.S.

Bear in mind that the Department of Energy (DOE) has never denied an LNG export application,

for environmental reasons or otherwise, and rejected a petition to do so just six months ago. President Biden could be pushing for more U.S. LNG exports, because the U.S. produces natural gas more responsibly and with fewer emissions than any LNG exporting country save Australia. However, despite the obvious fact that domestic gas has been a major driver of U.S. GHG emissions reductions and air quality improvements, the green cartels are trying to make the case that LNG exports will not do the same for other countries.

Also, serious questions surround the administration's legal authority to issue such an all-encompassing, job-killing freeze in energy exports. Congress has not authorized the DOE to take such drastic actions, which would have implications both inside and outside our borders. It is also absurd that the Natural Gas Act, a relic of 1930s-era policymaking, gives the DOE power to deny imports and exports, outside the bounds of trade agreements. States need to take the administration to the courts over this decision, and fortunately, many are already expressing a willingness to do so.

This LNG export ban may be the most strong-armed, authoritative action against American energy producers taken by an administration that has become known for such transgressions. Luckily, Congress is already working to reverse this massive mistake by advancing a bipartisan bill, Unlocking our Domestic LNG Potential Act.

It's notable when President Biden's anti-energy policies become so extreme that they elicit condemnations from members of his own party. By rolling back this executive action and ensuring the president cannot have unilateral control over vital energy production and exports, Congress would take a significant step to secure American energy leadership now and for years to come.

## Shelter grants can be made available

Many of my articles are on types of book reports or include my research, and this column on homelessness will be an example of this.

I recently met Martha Are of the Homeless Services Network (HSN) of Central Florida to discuss ideas of how to open a shelter in the Apopka area with a large tranche of federal dollars the county received as mitigation dollars for recent hurricanes. I will share some statistics from her organization and an insightful review of an article entitled, "A Tale of Two Tent Cities; the Critical Role of Housing Engagement in

Addressing Homeless Encampments," published in the Georgetown Journal on Poverty Law and Policy from Spring of 2023.

The Homeless Services Network leads Central Florida's efforts to house people experiencing homelessness and to help them remain housed. They run

a centralized intake system through the region and help draw down millions of dollars in federal funding for homeless housing. They partner with dozens of nonprofit agencies and local government partners to coordinate outreach, emergency shelters, transitional housing, and other resources. Martha is assisting me with the shelter grant opportunity. It will be challenging, and I ask your prayers for success.

Just in 2023, the HSN launched an \$8.4-million initiative to help prevent and end homelessness

## UF to announce acceptances Feb. 23

Though many seniors have already received most of their college acceptance decisions by this time of year, students who applied to the University of Florida had to wait until this Friday to get that decision.

If this year is anything like recent years, I'm afraid many students will end up disappointed since UF has become increasingly difficult to get into. For example, last year the students who were accepted had an average GPA between 4.4 – 4.6 (UF's weighted recalculation), SAT scores between 1340-1490 or an ACT score between 30-34.

The University of Florida is not alone in our state for being difficult to get into. Florida State University and University of Cen-

tral Florida are increasingly difficult as well. As we face this reality, it's important to remember that entering a four-year university as a freshman right after graduation is not the only way to a successful future.

This is the message I try to share with parents and high school students every day. There are many paths to success and the mentality that a student is only successful if they go

to a university at age 18 is one that is past its prime. The conversation has shifted and it's time for parents to get on board.

Two years ago, my own daughter found herself sitting with a denial letter from her dream school, FSU. Even as a child who had received many private college acceptances, our state university did not accept her high GPA, high ACT score and winning national debate record. For a smart, driven kid, this was a hard pill to swallow.

But she found solace in the fact that she wasn't alone, as several of her friends didn't get the acceptance they were after. So, she changed her per-



among 1- to 24-year-olds. The effort included housing, educational support, career training, and mental and physical healthcare. They also coordinated shelter and transportation during freeze warnings and distributed cooling supplies during the record-breaking summer heat. 99 percent of their funding goes to help people get stable housing.

Many of you have been reading about a bill in the state legislature to force municipalities without any funding to create homeless camps. This "book report" will discuss this method of dealing with homeless persons and make recommendations for more productive strategies.

In "A Tale of Two Tent Cities," the authors state, "Local governments have essentially three choices in responding to the presence of homeless encampments:"

1) They can adopt a law enforcement approach forcing individuals to move their camps on pain of arrest for trespassing.

This method does not solve the problem of people

without homes, and a recent court decision limits the ability of government to pursue it unless there is adequate space in a shelter. We have read about this in the case of Altamonte Springs.

2) A municipality can adopt an "out-of-sight, out-of-mind" approach, designating a specified area where homeless individuals are permitted to camp. The article delineates several examples of this from Gainesville. The camps can be a petri dish for crime, drug abuse, sexual abuse, and more. The cost of law enforcement's daily trips to referee are also substantial. This is the process the legislature is currently proposing.

3) The third choice is a housing engagement approach designed to get people out of homelessness and into housing. It substantially reduces the hidden costs of tent cities, encampments, and promotes a pro-social, well-regulated environment. However, it takes a truly organized and committed local government.

If I can find the time to write more about the

Gainesville camps examples, I will. I currently believe we need to fund the capital costs for a shelter replete with the HSN management systems and require the three new approved affordable housing projects in northwest Orange County to rent to a number of these homeless. If the municipality begins to take in more than their fair share from nearby counties and jurisdictions, they can always resort to option number one. I do believe we can manage to find some affordable housing options for homeless persons. Most of the homeless persons have some sort of funding, albeit Medicaid, Medicare, or Disability and can pay some amount of rent.

I'm terribly concerned when we see one-third of the homeless in our area being women with young children. The cost of doing nothing is too great, and with the state legislature knocking at our door to establish "camps," building a shelter and finding housing options sure seems superior.

I would love to hear your thoughts.



# City: Only one proposal was received in January bid request

town Apopka. The event space would remain wholly owned and operated by the city of Apopka.

The proposal comes in response to the request for proposal (RFP) the city had advertised last month. The RFP sought plans for completing a multi-use project, including affordable housing, downtown public parking, and extension of the Downtown Apopka Trail, and construction of public event space. The city wants to retain about one acre of land, which the successful proposer would develop as a public event space. Standard Investments & Holdings was the only company to submit a bid.

"There are a few hurdles that do have to be taken care of in regard to the brownfields, which is actually in that location of the plaza itself," Jim Hitt, city community development director, said at the City Council meeting. "There are some different fund-

ing mechanisms and also different methods to take care of that, which usually is just considered what's commonly referred to as a cap. That's basically cement covering the polluted area. There are a couple of monitoring wells on the site right now. So those would basically be continued on city property that would remain as city property."

According to city documents, the proposal was reviewed and deemed consistent with the proposal request and property disposal requirements that the Apopka CRA and City Council approved on October 18, 2023.

The Apopka Station Street Project proposal and use of the site is consistent with the comprehensive plan which shows the site as commercial. The land development code for zoning is Mixed Use-Downtown (MU-D).

Both Land Use and Zoning permit multifamily developments and adhere to the Senate Bill 102, known

as the Live Local Act, to allow for a maximum of 25 dwelling units per acre for the apartment site area, according to city documents.

Resident Ace Woodham restated at the City Council meeting what he said at the CRA meeting, which was that the city should reconsider the project in a way that would give emergency vehicles easier access to the area. Woodham clarified that he's not against the project.

"I'm not against the project, but I think we'd need to think about emergency vehicles before we go any further with tying all that land up because y'all got trees planted in the middle of Central Avenue," he said. "You cut the corners off there, made them a very






## District will give Lake Apopka update

An update on the continuing restoration of Lake Apopka will take place at Harry P. Leu Gardens, 1920 North Forest Ave., Orlando, in the Camellia Room on Thursday, March 21, at 7 p.m.

Organized by Orange Audubon Society, the pre-

sentation will be given by Dr. Erich Marzolf, director of the District's Division of Water Resources for St. Johns River Water Management District (SJRWMD). He has been actively involved in restoring Lake Apopka since 1996, when the State Legislature au-

thorized the District to purchase the farms to restore them to wetlands.

Vegetable farms, which were established on 20,000 acres that were formerly part of Lake Apopka, were purchased by the SJRWMD in the late 1980s and 1990s to restore water qual-

ity in the lake.

By halting nutrient inputs, restoring filtering marshes, removing bottom-feeding gizzard shad and other efforts over at least 20 years, the District has significantly improved the lake's water quality.

will surely be inspired by this keepsake for decades to come."

Akerman was a prominent defense attorney who played a pivotal role in the legal proceedings of the Groveland Four case, one of the most notorious racial injustice cases in Florida's history.

Akerman was a member of the prestigious legal team led by Thurgood Marshall. Other lawyers on the team included Jack Green-

berg and Paul Perkins Sr.

The Groveland Four were African-American men wrongfully accused of sexually assaulting a white woman in Lake County in 1949. Akerman's dedication to justice led him to defend these men, despite the challenging circumstances of the time.

"Alexander Akerman Jr. was not just a defense attorney; he was a symbol of resilience and commitment to justice. His efforts in the Groveland Four case are etched in the leg-

acy of legal history." Brinkle said. "This desk will serve as a tangible reminder of the struggles for justice and equality. It's a connection to our past and an inspiration for the future legal minds that pass through these halls of the FAMU College of Law."

Akerman was considered a civil rights pioneer taking racially motivated legal cases that other attorneys would not touch.

He is also credited with filing the lawsuit for Virgil Hawkins against the

University of Florida for denying him entry.

Akerman also represented five additional students who hoped to integrate graduate and professional programs at the University of Florida

As a result of the lawsuits, in December of 1949, the FAMU College of Law, College of Pharmacy and Pharmaceutical Sciences, College of Engineering, and graduate program in Agriculture were created.



sharp turn. I think you need to really look at that for it goes much further than that.”

Now that the Station Street Project proposal was accepted, the next step of reviewing and formally approving the development agreement would be scheduled for the CRA and City Council to do at separate

meetings on March 6.

The major development plan approvals will be completed in accordance with the city land development code and approved by the Apopka Planning Commission and City Council later this year. The construction site plan is completed and approved by the Development Review Committee in accordance with the land development code.

Located downtown, the Apopka CRA is comprised of 644 acres that has a mix of residences, businesses and historic properties. The CRA is bound on the south by Tenth and 11th Streets, Hawthorne Avenue to the west, Oak Street to the north; and sections of multiple streets to the east including but not limited to Highland Avenue, Monroe Avenue and Alabama Avenue.

The Apopka Community Redevelopment Agency Board directs the agency. The board is comprised of the Apopka City Council, an Orange County Board of County Commissioners representative, and other individuals appointed by the local government.

In August 2023, the Apopka CRA Board approved its fiscal year 2024 budget worth \$4.2 million.

## Orange County unveils plan to rid traffic fatalities by 2040

Each year, more than 42,000 people are killed on American streets, and thousands more are injured. In 2022, there were 209 fatalities and 1,208 severe injuries on Orange County roadways, as the Orange-Kissimmee-Sanford metro area continues to rank as one of the deadliest regions in the United States.

In 2022, the Orange County Board of County Commissioners voted to adopt a resolution to develop a Vision Zero Action Plan to eliminate all traffic fatalities and severe injuries by the year 2040 while also increasing safe, healthy, equitable mobility for all. First implemented in Sweden in the 1990s, Vision Zero has proved successful across Europe and is now gaining momentum in American cities.

The Orange County Vision Zero Action Plan is part of a regional effort by MetroPlan Orlando to reduce traffic fatalities and severe injuries, creating safer roads for both the 2.2 million residents and 75 million tourists who visit the region annually.

Coordinated Vision Zero Action Plans will be created for cities and counties throughout the region, made possible by a \$3.8 million federal Safe Streets for All (SS4A) grant.

“Safety is important to everyone, and

transportation and infrastructure create the means for the community to connect,” Humberto Castellero, Traffic Engineering Division Manager, Orange County Public Works, was quoted as saying in a press release. “We’re designing roads and educating people to ensure we have a holistic transportation system that enhances quality of life for all residents.”

While waiting for the plan to be finalized, Orange County Mayor Jerry L. Demings and county commissioners passed an Accelerated Transportation Safety Program, allocating \$100 million to implement traffic safety improvement projects that enhance sidewalks, lighting, speed management, pedestrian safety, access management and traffic calming.

Vision Zero recognizes that people sometimes make mistakes, so road systems and related policies should be designed to make sure human error doesn’t result in severe injuries or fatalities. As such, system designers and policymakers are expected to improve the roadway environment, policies and other related systems to lessen the severity of crashes.
